From June 20th until October 1st, you cannot be evicted for non-payment of rent, only if you cannot pay rent due to COVID-19, or if you qualify for unemployment benefits. If you've talked to your landlord and you still receive an eviction notice, you should contact the Department of Investigation's Bureau of City Marshals at 212-825-5923.
