General APA Guidelines. Your essay should be typed and double-spaced on standard-sized paper (8.5" x 11"), with 1" margins on all sides. You should use a clear font that is highly readable. APA recommends using 12 pt. Times New Roman font. Include a page header (also known as the "running head") at the top of every page.

Put the word "Abstract" centered in regular type on the line above the paragraph. You should write the abstract after you're finished with the paper, put position it on its own page just after the title...

The APA official stylebook suggests that the appendix should include information that would be distracting or inappropriate in the text of the paper. There are five levels of heading in APA Style. Level 1 is the highest or main level of heading, Level 2 is a subheading of Level 1, Level 3 is a subheading of Level 2, and so on through Levels 4 and 5. The number of headings to use in a paper

depends on the length and complexity of the work. If only one level of heading is needed, use Level 1.

### **Headings - APA Style**

Insert page numbers justified to the right-hand side of the APA format paper (do not put p. or pg. in front of the page numbers). For all pages of the paper, including the APA format title page, include the "TITLE OF YOUR PAPER" justified to the left in capital letters (i.e., the running head).

A reference list is a complete list of references used in a piece of writing including the author name, date of publication, title and more. An APA reference list must: Be on a new page at the end of the document. Be centred. Be alphabetically by name of first author (or title if the author isn't known, in this case a, an and the should be ignored)

How to Cite an Unpublished Paper in APA referencing. In APA referencing, you can cite an unpublished work in the same way as you would a published one. This means giving an author's name and a date in brackets. The only difference is that you give a year of production (i.e., when the paper was written) rather than a year of publication:

An APA abstract is a one paragraph ( $\pm$  250 words) summary of your paper. It introduces the objective or problem statement of the paper and includes information on the method, research results, and conclusions of your research. In a separate article we explain in-depth how to write an abstract.

### **APA Format for Academic Papers and Essays [Template]**

APA research papers contain sections including a title page, abstract, body and references page. The title page functions as the document's cover and includes the title of the paper, the writer's name and the name of the institution.
